# Request for Nominations for the 2016 Journey of a Lifetime

The Trustees of Journey of a Lifetime (JoLt) are looking for disabled and disadvantaged youngsters who could benefit from participating in a month-long, challenging "Journey of a Lifetime". We have already run successful journeys for more than 25 years to many different locations:

July/August 1984 - Across Siberia, Mongolia and China to Hong Kong.

July/August 1986 - Across the Australian Outback from Adelaide to Darwin.

July/August 1988 - From Colombia through Ecuador, Peru, Bolivia and Paraguay to Brazil.

July/August 1990 - Two groups (i) Across Canada ii) Zimbabwe and Botswana.

July/August 1992 - Along the Silk Road from Beijing in China to Islamabad in Pakistan.

July/August 1994 - Route of the Gold Rush from Los Angeles to Alaska.

July/August 1996 - Central and South America.

July/August 1998 - Lebanon, Syria, Jordan, Israel and Egypt.

July/August 2000 - The length of Chile.

July/August 2002 - Vietnam, Cambodia, Laos and Thailand.

July/August 2004 - The length of New Zealand.

July/August 2006 - A Himalayan Adventure – North India, Nepal, Tibet and Bhutan.

July/August 2008 - Through Southern Africa – Namibia, Lesotho and South Africa.

July/August 2010 - Tip to Tip to Top of Borneo and Brunei

July/August 2012 - From the Atlantic to the Pacific through Peru, Bolivia, Paraguay and Brazil

July August 2014 - Across Africa from Zambia, through Botswana, South Africa to Mozambique

# The 2016 "Journey of a Lifetime" is planned to travel through Indonesia and Northern Australia

The group will consist of

- Up to 18 physically, medically, emotionally or socially disadvantaged youngsters i) from the UK.
- Six experienced leaders, including two doctors. (ii)

#### **Conditions for Qualification**

The youngsters who go on JoLt 2016 must be:

- 1. Aged 14-21 years.
- 2. Physically, medically, emotionally or socially disadvantaged.
- 3. Excited at the prospect of travelling to distant lands.
- 4. Unlikely to have the opportunity to travel extensively without JoLt.
- 5. Free from involvement with the law or police prior to the journey for any offence that they have committed.
- 6. Not involved with drink, drug or solvent abuse.
- 7. Willing to actively contribute to make the journey a success, and likely to significantly benefit from the 2016 "Journey of a Lifetime".

The Trustees are particularly interested in taking youngsters who have one or more of the following disadvantages:

- deafness or hearing difficulties
- " blindness or visual impairment
- " a chronic medical condition or reduced life expectancies
- " physical disabilities which may or may not require a manual wheelchair (need to be reasonably mobile, **unfortunately powered wheelchairs are not suitable for a journey of this type)**
- " not known normal family life
- " struggled to overcome problems
- " experienced neglect and abuse
- " are young carers

Trustees welcome nominations of young people of every religion (or none) and of every race.

#### **The Cost**

Each person is given the challenge of raising £650 by their own efforts towards the cost of his/her journey. The remaining cost (approximately £5,000 per youngster) is paid for by JoLt. Major sponsors have included: The Clover Trust, The Hedley Foundation and Nexen Inc.
